2024 - 2025 EYC Board of Directors Election Process

It is the time of year to begin the process for the election of the EYC Board of Directors. The Board consists of: Commodore, Past Commodore, Vice Commodore of Sail, Vice Commodore of Power, Secretary, Treasurer, Social Director, and four Directors. As stated in the EYC By-Laws, "The Officers and Directors shall have authority over the management of the affairs and finances of the Club."

All positions are elected for a one-year term, except for the Directors. Directors are elected for a two-year term with two Directors being elected each year.

Most of the Officers and Directors are willing to serve again in 2024, but any EYC Member in good standing can be put on the ballot for any of the positions.

Ballots will be sent out at the end of November. If anyone is interested in serving on the Board and being put on the ballot, please let us know. The option to write-in a name will also be available on the ballot.
